The finishes CORTEN (burnished) and ANTIQUE GOLD are the result of a procedure of natural oxidation. The procedure is every time affected by the percentage of humidity in the air, by the external temperature and by other environmental variables. Hands of man and a special processing are a value added, which is evidence of the real 'Made in Italy'.

As in all works where the procedure is not mechanical but handcrafted, variations are possible, but they must not be considered as a defect, but rather as a proof of the uniqueness of the product. The Corten and Antique gold finishes makes the product as unique, since every results is not reproducible in identical way. The pictures of our catalogues are only an example of the kind of the product, but they cannot be considered strictly as samples of them, since the result can be different.

The procedure is every time affected by the percentage of humidity in the air, by the external temperature and by other environmental variables. Hands of man and a special processing are a value added, which is evidence of the real 'Made in Italy'. As in all works where the procedure is not mechanical but handcrafted, variations are possible, but they must not be considered as a defect, but rather as a proof of the uniqueness of the product. Corten finish makes the product as unique, since every results is not reproducible in identical way. The pictures of our catalogues are only an example of the kind of the product, but they cannot be considered strictly as samples of them, since the result can be different.

**3. Delivery Terms**

**4. Price and payment terms**

The law applicable to the Agreement is Italian, being expressly excluded the application to the Agreement of the Vienna Convention of April 11, 1980 on the International Sale of Goods being hereby expressly excluded (with the exception of art. 11 thereof regarding the agreements' freedom of forms, which shall apply).

Under no circumstances, any defects of the products, even if expressly recognized by AZIENDA, as well as any delays in meeting the delivery terms, will give the Purchaser the right to suspend the payments, and/or any other payment due to AZIENDA under this Agreement or other contractual relationships (estoppel clause pursuant to art. 1462 cc).
